SITUATION REPORT

INCIDENT NAME: Davis Block & Concrete Truck Rollover

SITREP #: 2 & Final

SPILL NUMBER: 07239918401

LEDGER CODE: 14236860

TIME/DATE OF SPILL: According to the Alaska State Troopers, the truck rolled over at approximately 5:19 AM on July 3, 2007. The spill was reported to the ADEC by State Troopers at 6:30 AM.

TIME/DATE OF SITUATION REPORT: 2:00 PM, August 31, 2007

TIME/DATE OF THE NEXT REPORT: This is the final report.

TYPE/AMOUNT OF PRODUCT SPILLED: The PRP estimates that less than 50 gallons of diesel, and approximately 10 gallons motor oil and 10 gallons glycol was released.

LOCATION: Mile 52 Sterling Highway near Cooper Landing, Alaska

CAUSE OF SPILL: A semi truck was hauling a shipment of concrete block and an empty concrete trailer, north bound on the Sterling Highway from Soldotna en route to Anchorage when the driver lost control of the vehicle. The truck ran off the side of the road with fuel leaking through one of the tank vents and other liquids released due to the accident.

POTENTIAL RESPONSIBLE PARTY (PRP): Davis Block & Concrete Company

RESPONSE ACTION: The truck and trailers were removed from the site by Weaver Brothers on July 3, 2007. Sorbent pads and boom placed in the area to prevent any contamination from migrating to the Kenai River. Foster Construction was contracted for cleanup with oversight by Rozak Engineering and contaminated soils were excavated and transported to Anchorage for remediation.

SOURCE CONTROL: Truck and trailers have been secured and removed from the site. Sorbent pads and boom were placed in the pond for containment by the ADEC responder.

RESOURCES AFFECTED: The area affected is approximately 20 ft. x 25 ft. of ground near an unnamed pond. The pond empties into the Kenai River through a culvert. No oil flowed into the Kenai River.

FUTURE PLANS AND RECOMMENDATIONS: Thermal remediation of contaminated soils in Anchorage.

WEATHER: Partly cloudy with high temperatures in the low 60s.
