TYPE/AMOUNT OF PRODUCT SPILLED: Gasoline, unknown amount at this time; vessel tanks will be sounded when vessel arrives at the ferry dock in Homer today.

LOCATION: Approximately 1mile SSE of KPL dock Nikiski, Central Cook Inlet, at 60° 40.36N - 151° 24.54 W

CAUSE OF SPILL: K-Sea Transportation reported that while departing KPL dock in Nikiski, the 48,000 bbl barge SCT 282 and its towing vessel the Pacific Challenger collided causing an approximately 4-6 inch x 3/16 inch crack two to three feet above the water line on tank Port #2

POTENTIAL RESPONSIBLE PARTY (PRP): K-Sea Transportation Partner L.P., Seattle, Washington

RESPONSE ACTIONS: ADEC and USCG personnel responded to KPL dock to investigate incident and look for visible sheen from the vessel. USCG examined OSK dock area and Captain Cook State Park access points with no visible impacts observed.

SOURCE CONTROL: A temporary epoxy patch was applied over damaged area

RESOURCES AFFECTED: Waters of Cook Inlet.

FUTURE PLANS AND RECOMMENDATIONS: Barge SCT 282 will dock in Homer for a vessel inspection. Permanent repairs will be determined after extent of damage has been evaluated.
